## **CBI Management Plan**

<u>Volunteer Leadership</u>: The Vice President of Endowment (presently Amy Corton) is the volunteer primarily responsible for the Leave a Legacy Program and the Planned Giving Program of CBI. The ELI Committee (Betty Byrnes, Amy Corton, Barbara Haworth, Jeff Silberman, Ann Mound and Stuart Simmons) is primarily responsible for defining the Leave a Legacy Program and the Planned Giving program and developing volunteers to work on the goals of the programs. The Endowment Committee (see attached list) acts as an advisory committee to the ELI Committee and the Vice President of Endowment. The Vice President of Endowment reports to the Executive Committee and the Board of Directors regarding the programs.

<u>Staff Leadership</u>: The Executive Director of CBI, Stuart Simmons, is primarily responsible for The Leave a Legacy Program and the Planned Giving Program. Beverly Miller is the staff person specifically assigned to the ELI Committee and the Planned Giving Program. She will keep the data bases and provide assistance to the ELI Committee, the Endowment Committee and the Vice President of Endowment. Rabbi Citrin will act in a leadership role by advising the committees and in cultivating families. The staff will report to the Vice President of Endowment and the Board of Directors regarding their responsibilities.

CBI is looking into hiring a Director of Endowment and Member Relations in the near future. Once that person is hired, they will be primarily responsible for our Leave a Legacy Program and Planned Giving Program.

The volunteer leadership will be responsible for:

- developing the CBI Leave a Legacy Plan,
- prospecting for families to leave estate gifts,
- educational programs for congregants,
- cultivation of families,
- asking for gifts
- thanking families.

The staff will be responsible for:

- all the foregoing responsibilities of the volunteers
- managing the CBI Leave a Legacy Plan
- developing systems to track progress and giving.
