Funding Application

The Jeffrey D. Sollender College Scholarship was created in memory of Jeffrey D. Sollender, a renaissance man who always put his family first. Mr. Sollender was a highly accomplished, creative entrepreneur who believed strongly in strengthening and improving the community and helping others achieve their dreams.

This program provides one - two scholarships totaling up to \$3,000 to graduating high school seniors who meet the program requirements listed below. Scholarship funds will be paid directly to universities and may be applied to college tuition, room and board, and fees. Open to all faiths.

Scholarship Eligibility

Student must:

- be a graduating high school senior in San Diego County who plans to attend an accredited four-year college or university;
- have demonstrated outstanding achievement in the workplace, entrepreneurial ventures, or community service;
- have a minimum 3.0/4.0 GPA;
- have a gross family income of no more than \$90,000 per year.

This scholarship is granted without any commitment of future financial assistance. Awards are made annually and may be renewed based on eligibility, demonstrated need and funding availability. Graduate study will not be considered.

During College

A minimum 3.0/4.0 GPA must be maintained while enrolled full-time at a four-year college or university. Student will spend at least 10 hours per week on his or her entrepreneurial endeavors, community service, and/or paid employment.

Student must provide the Jewish Community Foundation a copy of their college academic transcripts following each term as well as a 1 – 2 page statement describing a college, community service, work, or entrepreneurial experience, including what was learned and the impact it had on him/her.
